## OUR INTERNATIONAL PROGRAM





# FAQS

## What do I need to get started?

To start the process, it is necessary to have: Official Identification (Passport), Proof of Address, Birth Certificate, Marriage Certificate\*

## How soon until the trial begins?

Once we receive Phase 1 Initial Payment and the required personal documentation, the legal documents will be prepared and presented to the authority.


## How long does the trial take?

If resolved on the first instance, the average time is between 6 and 9 months. If another submission is required, the time may increase up to an additional 6 months.

## Where does the birth of the baby take place?

The birth of the baby and the process of obtaining the birth certificate will take place in the same city of the trial — either in México City and Tabasco. Additionally, any procedures\*\* to obtain passports or travel documents can be completed.
